Damien,

Thanks for your offer to request the extent of the financial guarantees (FGs) required by the various authorities. Please note that Orica will hold a total of \$A 130M insurance - \$70M primary and additional \$60M for marine.

1. We understand FGs will be required for the following:

- Danish EPA (Kommunekemi) - 6010 tonne waste in the application for two shipments in one year
- GOES (Sava) - 2130 tonnes waste in the application waste in the application for two shipments in one year
- Staatliches Umweltamt Itzehoe (Hafengesellschaft Brunsbuttel) - storage at the port of a maximum 1200 tonne waste

2. German FGs were approx. Euro 400 - 500 / tonne based on 50% of the annual volume in our earlier applications.

3. Hafengesellschaft Brunsbuttel (Brunsbuttel Port Store) - the licence suggest Euro 1.4 M for 16,000 tonne - on a proportional basis I assume this would be approx. Euro 90 per tonne.

4. It would be worth checking any specific requirements for the wording of the FGs. The German

Authorities were very particular. I have attached the FG prepared for Lanu, who was the competent authority for Sava. The specific wording which was required is in the section beginning: "IN CONNECTION WITH: THIS BANK GUARANTEE..."

Please let me know if you require any more information.
