Dear Andreas Wasielewski,

The Danish EPA has received a legal opinion of the Ministry of Environment of the State of North Rhine Westphalia (please see attached) from a Mr. Joachim Jürgen in Germany, in connection with an application from Australia to export HCB waste to Denmark.

We have unfortunately not been able to read the report in its entirety, but our understanding of the summary is that this is a memorandum/note dealing with the rejection of the application of HCB waste from Australia to Germany back in 2006. The main reason for rejecting the waste was that a properly reasoned motivation dealing with the possibility of Australia to handle the waste was missing. And that the argumentation provided by the Australia Government was not convincing with regard to reason that they did not have the capacity to handle the waste in question.

Denmark has in connection with the application from Australia received an independent report dealing with the capacity problem in Australia – We would like to ask you if you could clarify if we need to get any part of the legal opinion dated June 2007 translated into Danish to get any information of the capacity in Australia or if this note only deals with the interpretation of the Waste Shipment Regulation in connection with waste coming from a OECD country.
