#### Dear Mr. President

In all European Union Member States we are currently struggling to tackle the sovereign debt crises that has shaken markets and sparked unprecedented austerity and protests across Europe.

As national parliamentarians we are genuinely worried about the European project and deeply engaged in the struggle to get our economies back on a sustainable track - through the adoption of difficult structural reforms and sound fiscal policies.

Therefore when Europe in the near future moves into a more integrated financial, budgetary and fiscal union, we will find ourselves facing a very important democratic challenge.

Particularly the creation of the European Semester and the gradual move towards a fully fledged integrated budgetary and Economic framework will touch upon the very heart of national parliamentary democracy. But also a more integrated financial union call on national parliaments to reflect about their role in anchoring the EU democratically, because supervision, crisis management and resolution of banks are still very much organized along national lines.

Despite the European Council's recent call for strong mechanisms for democratic legitimacy and accountability, there is a worrying lack of proposals as to how the role of national parliaments can be strengthened more concretely. Members of national parliaments, being close to citizens, have a special role to play in establishing links between citizens of our Member States and European decision-making.

For that reason members of 11 national parliaments gathered in Copenhagen on 26 November to discuss how a more integrated financial, budgetary and economic union could be accompanied with strong mechanisms for democratic legitimacy and accountability. At our meeting we had an initial exchange of views on this question and various ideas were put on the table. We agreed that further involvement of national parliaments in the debate is necessary.

We would therefore like to discuss some of these ideas and proposals with you as to how national parliaments could be more actively involved in further strengthening the democratic legitimacy of the European Union. Finally we would like to thank you and the European Council for having included the important question of democratic legitimacy and accountability in the debate about shaping a genuine economic and monetary union and not least for your commitment in the interim report of 12 October to securing the pivotal role of national parliaments in this regard.

We therefore look forward to hearing from you about how we can contribute to this important debate about the future of Europe. We remain at your disposal for any further information and would welcome to participate in any consultations you may find appropriate.
