Folketingets Social-, Indenrigs- og Børneudvalg har d. 08.09.2017 stillet følgende spørgsmål nr. 512 (alm. del) til børne- og socialministeren, som hermed besvares endeligt. Spørgsmålet er stillet på udvalgets vegne af Troels Ravn (S).

Spørgsmål nr. 512:

”Vil ministeren oversende en oversigt over antallet af tvangsfjernelser af børn og unge år for år siden 2007? Oversigten ønskes fordelt på postnumre.”

Svar:

En anbringelse uden for hjemmet er én af de foranstaltninger, kommunerne kan træffe afgørelse om, hvis børn og unge har brug for særlig støtte og behov for hjælp. Hvis der er tale om en frivillig anbringelse, træffes afgørelsen af kommunalbestyrelsen, mens anbringelser uden samtykke træffes af børn og unge-udvalget, jf. servicelovens § 58.

Tabel 1 viser en opgørelse over antallet af børn og unge i alderen 0-17 år, der er blevet anbragt uden for hjemmet uden samtykke i perioden 2007-2015.

Opgørelsen omfatter heller ikke formandsafgørelser, jf. serviceloven § 75. For nogle få personer findes der ikke cpr-oplysninger. Disse personer indgår ikke i opgørelsen.

Det bemærkes, at der ikke er opgjort tal for postnumre med meget få anbragte børn og unge som følge af de diskretionsmæssige hensyn, Danmarks Statistik underlægger brugen af registerdata. Opgørelsen omfatter desuden kun de postnumre, hvor mindst ét barn med registrerede adresseoplysninger er blevet anbragt uden for hjemmet uden samtykke i perioden 2007-2015.

Af det foreløbige svar, som Børne- og Socialministeriet tidligere har afgivet, fremgik det, at det forventedes, at et endeligt svar også ville omfatte data for 2016. Af tekniske årsager, der relaterer sig til de registre hos Danmarks Statistik, som opgørelsen er baseret på, er det imidlertid kun muligt at foretage opgørelsen frem til 2015 på nuværende tidspunkt.
