Progress report of the Bureau of the Assembly and of the Standing Committee (28 January – 25 April 2005)

Bureau of the Assembly Rapporteur: Mr Serhiy Holovaty, Ukraine, Liberal, Democratic and Reformers' Group

1. INTRODUCTION

1. The Bureau met on 28 January in Strasbourg and on 18 March in Paris and on 25 April in Strasbourg. The Standing Committee met on 18 March in Paris.

2. FUNCTIONING OF THE ASSEMBLY

- A. PROGRESS REPORT OF THE BUREAU OF THE ASSEMBLY AND OF THE STANDING COMMITTEE (28 JANUARY 25 APRIL 2005)
- 2. On 28 January, the Bureau appointed Mr Holovaty (LDR, Ukraine) as rapporteur.
- 3. On 25 April, the Bureau approved the Progress report covering the period from 28 January to 25 April 2005.
- B. FOLLOW-UP TO THE 1ST PART OF THE 2005 ORDINARY SESSION (24-28 JANUARY 2005)
- 4. On 28 January, the Bureau:
- i. addresses of Mr Viktor Yuschenko, President of Ukraine, Mr Mikheil Saakashvili, President of Georgia and Mr Michel Barnier, French Foreign Minister: asked the Secretary General of the Parliamentary Assembly to prepare a memorandum for the next Bureau meeting on the follow-up to be given by the Assembly to the proposals contained in these addresses;
- ii. Recommendation 1693 (2005) on the Third Summit: was informed that the President will address letters to the Speakers of the national parliaments calling on them, in conformity with paragraph 17, to organise debates on the Third Summit;
- iii. Resolution 1416 (2005) on the conflict over the Nagorno-Karabakh region dealt with by the OSCE Minsk Conference: asked the Secretary General of the Parliamentary Assembly to prepare a memorandum for the next Bureau meeting on the implementation of paragraph 5 with regard to:

- the composition of the ad hoc committee of the Bureau decided by the Assembly, which should include, besides the Chairpersons of the national delegations mentioned in this paragraph, representatives of the Committees concerned and, at the same time, representatives of all political groups of the Assembly;
- the precise mandate of this ad hoc committee;
- iv. Resolution 1420 (2005) on prospects for peace in the Middle East: asked the Secretary General of the Parliamentary Assembly to prepare a memorandum for the next Bureau meeting on the implementation of paragraph 12;
- v. Resolution 1415 (2005) on honouring of obligations and commitments by Georgia: took note that the President will address letters to the Speakers of the Russian and Georgian Parliaments offering, in conformity with paragraph 12, the Assembly's good offices for a bilateral parliamentary dialogue.
- 5. On 18 March, the Bureau:
- i. Addresses of Mr Viktor Yuschenko, President of Ukraine, Mr Mikheil Saakashvili, President of Georgia and Mr Michel Barnier, Minister for Foreign Affairs of France:
 - > took note of the memorandum prepared by the Secretary General of the Parliamentary Assembly and approved the proposals contained therein, in particular:
- a. Address of President Yuschenko:
 - welcomed the decision of the Presidential Committee to visit Kyiv, possibly at the beginning of July 2005;
 - decided, in principle, to set up a broadly based ad hoc committee to observe the parliamentary elections in Ukraine in March 2006;
 - invited the Assembly's committees to organise conferences and seminars, within their areas
 of competence and within the limits of the available budgetary resources, on the priority
 matters indicated by President Yuschenko in his address;
 - asked the Secretary General of the Assembly to examine the possibility of organising training seminars in the framework of the parliamentary co-operation programme;
- b. Address of President Saakashvili:
 - took note of the intention of the President of the Assembly to meet with the heads of the Russian and Georgian parliamentary delegations during the April 2005 part-session in order to help strengthen the bilateral parliamentary dialogue;
 - invited the Political Affairs Committee to consider organising a round table with the Georgian authorities and other parties concerned to discuss President's Saakashvili peace initiative announced in Strasbourg;
- c. Address of Mr Barnier, Foreign Minister of France:
 - took note of the action being taken by the President of the Assembly with a view to strengthening relations with the European Union;
 - agreed to invite Mr Barroso, President of the European Commission, as well as other members of the European Commission, to address the Assembly;

- asked the Committee on the Rules of Procedure and Immunities to make a proposal for the inclusion in the Assembly's Rules of Procedure of a new rule on co-operation with the European Parliament;
- invited the Political Affairs Committee to consider organising a colloquy on the Council of Europe's contribution to the European Union's new neighbourhood policy in the framework of the preparation of the report on the external relations of the Council of Europe;
- ii. Resolution 1416 (2005) on the conflict over the Nagorno-Karabakh region dealt with by the OSCE Minsk Conference:
 - > took note of the memorandum prepared by the Secretary General of the Parliamentary Assembly on the implementation of paragraph 5 of this Resolution;
 - established an ad hoc committee on the implementation of paragraph 5 of this Resolution as specified in the memorandum;
 - decided to come back to this matter at its next meeting with a view to approving the composition of this ad hoc committee and appointing its Chairperson;
- iii. Resolution 1420 (2005) on prospects for peace in the Middle East:
 - > took note of the memorandum prepared by the Secretary General of the Parliamentary Assembly on the implementation of paragraphs 12 and 13 of this Resolution;
 - invited the Assembly committees, except the Monitoring Committee, to consider the possibility of organising in their respective fields of action activities on issues of specific interest to representatives of the Knesset and the Palestinian Legislative Council;
 - invited the Political Affairs Committee to submit to it a proposal on the composition, programme and working methods of a tripartite forum under the aegis of the Sub-Committee on the Middle East involving an equal number of representatives from the Knesset and the Palestinian Legislative Council;
 - noted that the President of the Palestinian Authority has been invited to address the Assembly's April 2005 part-session;
 - > asked the Secretary General of the Assembly to consider, in close co-operation with his Palestinian counterpart, the possibility of organising training seminars for parliamentarians and staff members from the Palestinian Legislative Council.

 - took note of the decision taken by the Ministers' Deputies at the 921st meeting on 30 March 2005 concerning the item on the timetable for the election of the Council of Europe Commissioner for Human Rights;
- vii. Election of a judge to the European Court of Human Rights with respect to Latvia:
 - took note that the Sub-Committee on the election of judges to the European Court of Human Rights will only interview the candidates on Monday 25 April in the afternoon (at 1.30 pm) and agreed to the written consultation of Bureau members on this matter;
 - > urged the Assembly's political groups to ensure the best possible participation of their members in the meetings of the Sub-Committee on the election of judges to the European Court of Human Rights.

 - ratified the changes in the composition of general Assembly committees in respect of the delegations of Denmark, Latvia and Romania;
 - > took note of the agenda adopted and the draft order of business drawn up by the Bureau for the April 2005 Part-Session of the Parliamentary Assembly (25-29 April 2005);
 - > took note of the information provided by the President on the decisions by the Bureau on the procedure for the election of the Commissioner for Human Rights;

- v. decided to ask the Committee on Legal Affairs and Human Rights to organise the interviews of candidates in September 2005.

- 36. On 28 January, the Bureau:
- i. approved the modalities of the Assembly's involvement in the organisation of this conference and set up an hoc committee to participate in it composed of 15 members on the basis of proposals to be made by the political groups (6 SOC, 4 EPP/CD, 2 LDR, 2 EDG and 1 UEL);
- ii. was informed about the proposals for the draft programme and the draft final declaration received from the CIS Inter-parliamentary Assembly and invited members to formulate their possible comments regarding these documents.
- 37. On 18 March, the Bureau:
- i. approved the composition of the ad hoc committee to participate in this Conference;

- ii. took note of the draft programme of the conference and agreed to propose that Mr Ateş chair Panel 1, Mr Iwinski co-chair Panel 2 and Mr Van den Brande co-chair Panel 3;

A. BUDGET OF THE ASSEMBLY FOR 2006

- 38. On 18 March, the Bureau:
- i. following the proposal of the Committee on Economic Affairs and Development, proposed to the Assembly to hold the debate on the budgetary reports (on the budget of the Council of Europe as a whole and on that of the Assembly) in the Assembly after the Third Summit of the Council of Europe taking into account the Summit's decisions:
- ii. invited this Committee to consider the question of the Assembly's budget in the context of the Council of Europe's budget as a whole, taking into account the institutional balance, the statutory role of the Assembly within the Organisation and the cost effectiveness;
- iii. in this context, was informed by the President of the Assembly that the Secretary General of the Assembly has been asked by the Secretary General of the Council of Europe to make, by 31 March 2005, a proposal for the Assembly's budget for 2006 foreseeing efficiency savings of 2% in comparison to 2005 budget;
- iv. declared that it was against any reduction in the Assembly's 2006 budget and instructed the Secretary General of the Assembly to inform the Secretary General of the Council of Europe accordingly.

6. OBSERVATION OF ELECTIONS

A. PARLIAMENTARY ELECTIONS IN MOLDOVA (6 MARCH 2005)

- 39. On 28 January, the Bureau:
- i. approved the composition of the ad hoc Committee to observe these elections and took note of the dates for the pre-electoral mission, which will take place on 16-19 February 2005;

41. On 18 March, the Bureau took note of the exchange of letters between Mr Jurgens, President of the Council for Democratic Elections, and the President of the Assembly, and stated that in conformity with the cooperation agreement between the Assembly and the Venice Commission, the Bureau can ask the Venice Commission for opinions on specific problems concerning the election legislation which were highlighted by the Assembly election observation mission.

42. F. CONSTITUTIONAL REFERUNDUM IN ARMENIA (SUMMER 2005)

45. On 25 April, the Bureau set up an Ad Hoc Committee to observe these elections composed of 10 members (3 SOC, 2 EPP/CD, 2 LDR, 2 EDG, 1 UEL).

G. PARLIAMENTARY ELECTIONS IN BULGARIA (25 JUNE 2005)

- 46. On 25 April, the Bureau:
 - took note that Mr Passy, Minister of Foreign Affairs of Bulgaria, had sent a letter to the Secretary General of the Council of Europe inviting the Council of Europe to assess the need to send an observation mission to the parliamentary elections in Bulgaria;
 - asked that the Secretary General of the Parliamentary Assembly consult the Chairman of the parliamentary delegation of Bulgaria to the Assembly and agreed to come back to this matter at the meeting of the Bureau on Friday 29 April on the basis of this consultation.

7. OTHER MATTERS

A. EUROPEAN CONFERENCE OF PRESIDENTS OF PARLIAMENTS IN 2006

- 47. On 18 March, the Bureau:
- i. took note of the memorandum prepared by the Secretary General of the Assembly;
- ii. noted that, as a result of the consultations between the Secretary General of the Parliamentary Assembly and the Secretaries General of the parliaments of the countries from which formal invitations had been received, it was announced already by Mr Schieder, former President of the Assembly, that the next Conference of Presidents of Parliaments will be held in Tallinn from 30 to 31 May 2006;

- iii. welcomed the invitation from the Speaker of the Parliament of Finland to the participants at this Speaker's Conference to take part in the commemoration of the 100th anniversary of the first parliamentary session of the Finnish parliament, which will take place on 1st June 2006 in Helsinki;
- iv. agreed to the topic proposed by the President for this Conference, i.e. "Bridge-building through Parliamentary Diplomacy" and asked the President to transmit this proposal to the President of the Parliament of Estonia for consideration;

- 51. On 25 April, the Bureau took note of the information by the President of the Assembly, the Secretary General and the Deputy Secretary General of the Council of Europe and the Secretary General of the Assembly.
