Conference Background

Eutrophication is a problem of great concern for all parties around the Baltic Sea. Eutrophication leads to detrimental algae blooming, declining water transparency, Oxygen deficit, death of fish, and eventually to a very unpleasant or even toxic environment for human activities of all kinds.

Sources of the excessive nutrient discharge originate from agriculture, industries, households etc. of all countries around the Baltic Sea and the catchment area. The airborne contribution originates as well from countries further away.

Since eutrophication is a key challenge for the sound Baltic Sea environment the parliamentarians wish to steer a debate, driving eutrophication up the agenda as a tangible way in order to introduce efficient measures.
