Paragraphs 2 to 15 were agreed to.

The draft Resolution *The Situation in Georgia* [254 CDS 10 E rev. 1], as amended, was agreed to.

19. Presentation by Raynell Andreychuk, General Rapporteur of the Political Committee, of the draft Resolution *The Increasing Importance of NATO Partnerships* submitted by the Committee; debate and Vote on the draft Resolution [248 PC 10 E rev. 1]

**Raynell Andreychuk** (Canada ) presented the draft Resolution.

The draft Resolution *The Increasing Importance of NATO Partnerships* [248 PC 10 E rev. 1] was adopted.
