Questionnaire to OSCE Parliaments on Follow-Up to OSCE PA Recommendations

The following questionnaire is based on OSCE PA recommendations, particularly those passed during the Oslo Annual Session in 2010. We invite you to provide by 8 April 2011 an outline of action taken by your parliament and government in the areas listed below. Answers will be made available to all delegations in the interest of encouraging exchange of best practice, and will enable the International Secretariat to take account of developments across the OSCE region when compiling information on follow-up to the Oslo Declaration. Areas which have been enacted in recent months are of particular interest, although existing efforts are also of relevance.

In the field of combating transnational crime and corruption, please include information on:

- Steps to ratify and give full effect to obligations in relevant UN treaties and OSCE documents related to combating organized crime and corruptionⁱ
- Efforts to tackle corruption in public administrations, including parliaments, to ensure transparent lobbying rules, and to provide adequate financial and human resources to fight organized crimeⁱⁱ
- Steps to improve international co-operation in fighting organized crimeⁱⁱⁱ
- Steps taken to counter money laundering in relation to crime and terrorism^{iv}

In the field of political affairs and security, please include information on:

- Follow-up to OSCE PA recommendations by delegations at the national level^v
- Work on countering the proliferation of weapons of mass destruction^{vi}
- Measures to complete delimitation and demarcation of borders, to ensure full respect for territorial integrity, and to prevent illegal use of military forces abroad^{vii}
- Development and implementation of plans to promote gender mainstreaming in peace and security operations^{viii}

In the field of environmental and economic security, please include information on:

- Steps taken to improve the transparency and efficiency of the financial system at national and international levels^{ix}
- Steps taken to eliminate tax evasion and "safe havens" for illegally acquired funds^x
- Efforts to combat cyber-crime with full respect for freedom of expression^{xi}
- Efforts to support environmentally-sustainable practices, in particular concerning the Arctic region^{xii}
- Efforts contributing to attaining the Millennium Development Goals^{xiii}

In the field of human rights and democracy, please include information on:

- Steps taken to ensure the protection of journalists and persons who expose abuses and violations^{xiv}
- Efforts to combat trafficking in human beings and forced labour and to ensure protection of victims $^{x\nu}$
- Work aimed at managing migratory flows in the best interests of those involved^{xvi}
- Work to combat discrimination and intolerance, as well as ensure an effective separation between religious communities and the State^{xvii}
- Efforts to ensure full protection of human rights while carrying out the fight against crime and terrorism^{xviii}
- Steps to protect women's sexual and reproductive rights and ensure appropriate attention to the position of women migrants^{xix}
