

## **ROJ TV AS THE TRUMP AGAINST RASMUSSEN**

**In order to prevent Turkey's objection against the Danish Prime Minister's candidacy for the NATO General Secretariat, Roj TV closure has come on the agenda**

It is said that the Danish Prime Minister Anders Fogh Rasmussen, who had mismanaged the caricature crisis in his country due to which Turkey is objecting to his candidacy for the NATO General Secretariat, is trying to soften the environment through an interesting method.

According to the information we obtained, it is said that Rasmussen has taken a step with jet speed to have the closure case started against the Roj TV, which is making propaganda for the PKK terror organization in his country. It has been learned that the State Public Prosecutor Anders Riisager, conducting the interrogation on the matter, came to Ankara yesterday and collected information. The comments in the Danish political circles say that this was to soften Turkey's objections against Rasmussen's candidacy for the NATO General Secretariat.

### **Initiative to annul the Licence**

The dominant belief is that the case for the closure of Roj TV will be launched with jet speed upon Riisager's return from Turkey, which would be a gesture for Turkey by Rasmussen. Since 2004, Turkey has been making diplomatic initiatives to have the Danish licence of Roj TV annulled. Furthermore, in an article by the famous American journalist Stephen Kinzer Rasmussen's candidacy has been strongly criticized saying, "Turkey should not be forced to veto Rasmussen. This would mean disrespect on the part of the NATO to the Muslim world. Rasmussen's election should be prevented."

**CAPTION:** In a commentary in the Norwegian daily Aftenposten, Rasmussen was described as "a liar, bluffing, and Bush's puppy dog". Harald Stanghelle, in his commentary published yesterday, strongly criticized Rasmussen saying "Couldn't NATO find anything better than that?"






#### **Dagens presse**

**ONE YEAR HAS PASSED BY, THE PROMISES HAVE BEEN FORGOTTEN**

*Despite Turkey's 'victorious' appearance during the negotiations for the election of Rasmussen, the former Danish Prime Minister, at the 60<sup>th</sup> NATO Summit last year, attention is drawn to the fact that there has been nothing that can be marked in the accomplishment slot for Ankara.*

*In the historical NATO Summit held last year in Kehl and Strasbourg, the negotiations conducted for the election of **Anders Fogh Rasmussen** as the NATO Secretary General, had been the highlight. However, the promises he was said to have made on "the closure of Roj TV", "the apology to be made to the Muslim world", and "having Turkish diplomat and commanders in the high-ranking positions within the NATO" have not been kept.*

*Immediately before the Summit on April 3-4<sup>th</sup> where the new Secretary General was elected, Prime Minister Recep Tayyip Erdogan had stated to the world public opinion that he was against the Danish Prime Minister's taking the highest ranking position of the military alliance. As an explanation to his objection to Rasmussen, Erdogan had put forth the fact that ROJ TV, the media organ of the PKK terror organization, was broadcasting from Denmark; and that Rasmussen had not displayed an attitude that would eliminate the discomfort created in the Muslim world upon the publication of the caricatures on Prophet Mohammed in a newspaper in Denmark.*

*In the light of this development, during the Summit, US President **Barack Obama**, the German Prime Minister **Angela Merkel** and some other leaders put intense pressure on Turkey in order to make her accept Rasmussen, which they had previously determined as the Secretary General. Just before the Summit, Italian Prime Minister **Silvio Berlusconi** called Erdogan and talked to him on the phone for half an hour, trying to convince Erdogan. Finally, President **Gül**, who was representing Turkey at the Summit, had given his OK.*

#### **What was going to happen, and what actually happened?**

*This backward step taken by Turkey on the much argued summit, that had kept the world public opinion intensely occupied, was presented to the public opinion by the AKP government as a 'victory'. Prime Minister Erdogan personally stated to the public that Turkey had approved Rasmussen's election as the Secretary General because the Turkish requests were accepted under the guarantee of Barack Obama.*

Erdogan had stated that as a result of the negotiations with Rasmussen a Turk would be appointed as the Deputy Secretary General. According to the NATO sources, this expectation was not very realistic. It was said that the position of the Acting Secretary General was presently held by an Italian and that the chances of Italy giving up this position for Turkey's sake was very slim. Aside from the Acting Secretary General, there are 6 different deputy secretary generals at the NATO. One of these positions was vacated within the course of the last year. The Ministry of Foreign Affairs nominated Ambassador **Hüseyin Diriöz** to this position. However, not Hüseyin Diriöz but German **Dirk Bengelmann** was appointed to this position, as the head of the Political Affairs and Security Policy Unit. There will be 4 positions to be vacated by the end of the year and it is being wondered whether a Turk will be appointed to one of these positions.

Erdogan had also stated that promises were made for high-ranking commanding positions. Since then, French **Stephane Abrial** has been appointed to one of the strategic commanding positions, to which a Turk could have been appointed.

After the Summit, newspaper headlines had said that Rasmussen would participate at the Alliance of Civilizations meeting in Istanbul and would apologize to the Muslim world. However, at this forum Rasmussen sufficed by saying that "**he was sorry that the caricatures were perceived as insult and disrespect**".

In his speech, Rasmussen emphasized the freedom of expression and underlined that the decision on ROJ TV would be taken by the judicial authorities.

## Danish daily reveals one officer handling Roj TV inquiry

A Danish politician has criticized the government over the slow pace of the investigation into Roj TV, a satellite television station acting as a mouthpiece for the outlawed Kurdistan Workers' Party (PKK), after a Danish newspaper revealed that the investigation team consisted of one police officer.

Peter Skaarup, the vice chairman of the Danish People's Party, on Wednesday criticized the government and Justice Minister Lars Barfoed, claiming a special commission must be established to scrutinize the Roj TV investigation itself.

The Danish daily Berlingske Tidende, which has extensively written on Roj TV previously, ran a story on Wednesday claiming that only one officer has been assigned to investigate Roj TV's alleged links to the PKK. The newspaper

asserted that this is the primary reason why the case has been continuing years despite repeated calls from Ankara for measures to be taken against Roj TV. Danish authorities have responded to Turkey's calls, saying the investigation should first be concluded.

Roj TV, which Turkey has long said is a mouthpiece for the outlawed PKK, continues to broadcast with a Danish license. The daily also reported the same officer is also busy collecting evidence on criminal gang warfare -- one of the Amsterdam's largest problems. Observers note this illustrates the country's indifference to the case.

In early April of last year, former Prime Minister Anders Fogh Rasmussen, who is now NATO's new secretary-general, faced opposition to his appointment from NATO-member Turkey due to the way he handled the infamous "cartoon crisis" in 2006 and his country's indifference to Roj TV's links to the terrorist organization. Rasmussen also had a personal clash with Prime Minister Recep Tayyip Erdogan in 2005 when Danish authorities refused to bar a reporter from Roj TV from a conference hall where Erdogan and Rasmussen were scheduled to hold a joint press conference. At the last minute Erdogan refused to attend the conference.

"Usually, terror investigations have a privilege in terms of priority. Both intelligence agencies and police jointly work in coordination. But it seems there are many faults both in coordination and cooperation with respect to this particular investigation," Skaarup said.

Danish prosecutor Lise-Lotte Nilas, who has ultimate say in the investigation, is expected to present his assessment to the Justice Ministry, but it is not yet known when he will do that. Speaking to Today's Zaman last week, Nilas said the completion of the investigation will be in a "matter of months." However, Justice Minister Barfoed said while he was testifying before the Danish Parliament's Law Commission last month that he had no idea why the Roj TV investigation was taking so long.

*In his speech, Rasmussen emphasized the freedom of expression and underlined that the decision on ROJ TV would be taken by the judicial authorities.*

## **THE ROJ TV BRIBE**

**The Danish Prime Minister, who wants to become the Secretary General for the NATO, understood that he would get a veto from Turkey. He played the Roj TV closure card**

The Roj TV operation from Rasmussen! The Danish Prime Minister, whose NATO carrier depends on Turkey, is trying to get over the veto through Roj TV. Rasmussen, who had until yesterday been extremely protective of the separatist channel that is broadcasting over his country, has taken a backward step for his career.

## **THE ELECTION AT THE NATO MADE THE ROJ TV REMEMBERED**

**Rasmussen, who would not close Roj TV for years and who would not take a back step in the caricature crisis, changed his route when the General Secretariat for the NATO, has come into the picture. The Danish Prime Minister sent his prosecutors to Ankara; [coming to] Istanbul in April.**

The Danish Prime Minister remembered that Roj TV was the “media organ of the PKK” when it appeared that Turkey could “possibly veto his becoming the Secretary General for the NATO”. Rasmussen sent two of his high-ranking public prosecutors to Ankara on the day he had a telephone conversation with Prime Minister Recep Tayyip Erdogan.

The Foreign Ministry Spokesman, Burak Özügergin, also confirmed that the Danish prosecutors had come to Ankara; and he maintained that this was previously planned and it should not be linked to the process of Rasmussen’s General Secretariat for the NATO. It has been learned that the Danish prosecutors had meetings at the Ministry of Justice and Ministry of Internal Affairs.

## **A never-ending long story**

The closure of Roj TV has been dragging for the last four years. On several occasions, Denmark had requested new evidence from Turkey upon finding the presented documents insufficient. The governments of the two countries had agreed that Turkish prosecutors and police officers would go to Copenhagen and would explain the process to the authorities in Copenhagen. However, nothing had come out of this, either.

Along with the Roj TV, caricature crisis had also been experienced between Turkey and Denmark. 12 caricatures were published in a newspaper in Denmark in 2005, which depicted Prophet Mohammed in an insulting manner; and over 20 countries, including Turkey, had sent protest letters. And, Rasmussen had said: "We have freedom of expression; I cannot do anything."

### **How can I explain this to my people?**

In the live program on NTV, which Erdogan participated the previous evening, he conveyed what he said to Rasmussen in the following manner: "A very serious reaction has formed in the countries, whose people are Muslim; and, these countries have started calling us and telling us, 'don't you do it'. Unfortunately, this is the reflection of those days to the present. And, the other point is Roj TV. I called you on the phone in connection with the caricature crisis. Why had you not opted for calling the ambassadors of the Muslim countries, explaining to them that you would do whatever was required? Why had you not given me a favourable response? During my visit to you in Denmark, I brought up the Roj TV issue. There, you put in front of me the Danish laws. It has been 4 years, and you have not been able to conclude the matter. But now different things are being discussed. On April 3-4, in Brussels or perhaps in France, a decision will be taken on this issue. My primary duty would be to explain this to my people. I should not be in contradiction with the principles of my party; and it is up to your discretion to understand what this would mean."

## **HAS STEPPED BACK FROM ROJ TV FOR THE SAKE OF THE NATO CHAIR**

**The Danish Prime Minister Rasmussen, who had said "we have freedom of expression" in response to Turkey's efforts to have Roj TV closed, has retreated due to the "veto" threat for his Secretary General to the NATO. Yesterday Rasmussen stated that he would send two high-ranking prosecutors to Turkey to discuss the closure of Roj TV, the media organ of the PKK**

Prime Minister Recep Tayyip Erdogan has presented the Roj TV as the trump against Rasmussen, who wishes to become the Secretary General for the NATO. Prime Minister Erdogan supported his Roj TV trump with the caricature crisis. Erdogan pointed out that Anders Fogh Rasmussen had called him and that they had talked on the phone; criticizing the fact that Denmark had been unable to solve the Roj TV issue for the last 4 years, he stated that he had told him that "he had not taken favourable steps". Erdogan also conveyed that he had told Rasmussen that he did not want to be in contradiction with the principles of his party and that he needed to be able to explain it to the people.

In the live program on NTV, which Erdogan participated the previous evening, he responded a question related to Rasmussen's candidacy to the General Secretariat of the NATO.

Erdogan, who did not at all touch upon the PKK crisis during his visit to Denmark, said the following: "He called me; it seems he had been calling for the last few days, we had not been able to talk. I expressed the discomfort in the society. We do not want the NATO to be worn [tired] out. We would not want you be worn out as a Prime Minister, either. With the caricature crisis, there had been reactions against you. Muslim countries are calling us and saying "don't you do it". I told him that I had told him certain things in connection with the Roj TV. I told him that he had not taken favourable steps. You had put in front of the Danish laws. We said that they had not concluded this matter for the last 4 years. But now they are talking about different things. It was a lengthy talk. A decision would be reached on the 3<sup>rd</sup>. I told him that my primary duty would be to explain this to my people. I should not be in contradiction with the principles of my party; and it is up to your discretion to understand what this would mean."

### **We have been trying since 2004**

Rasmussen, who Turkey has been accusing of mismanaging the caricature crisis, has now started taking action, in order to get Turkey's support as well for his becoming the Secretary General for the NATO. He talked on the phone with Prime Minister Erdogan and he is also planning to promptly launch the closure case against the Roj TV, which could not have been launched for a long time. For this purpose, Rasmussen has sent a public prosecutor to Turkey so that he would collect information.

Turkey has been taking diplomatic initiatives since 2004 so that the broadcasting license of Roj TV, obtained from Denmark, would be annulled. Turkey wants the termination of the broadcasts of Roj TV, which continues its broadcasts with the license obtained from Denmark; and for this purpose, she had applied to the Danish Radio and TV Board. However, Denmark has started an investigation pointing out that a court decision was necessary to terminate the broadcasts of Roj TV and to have its licence annulled. And, Turkey conveyed to Denmark information, documents, and materials, by the Ministry of Justice and through the Embassy in Copenhagen, so that the case against Roj TV could be launched promptly. However, so far Denmark has not taken a concrete step to have the case launched.

### **If Rasmussen gets elected his income will increase by USD 25 thousand**

If the Danish Prime Minister Anders Fogh Rasmussen gets elected as the Secretary General for the NATO, he would not only be profiting politically but financially as well. At present Rasmussen is making USD 175 thousand annually and if he gets elected as the Secretary General his annual salary will increase to USD 200.

### **Denmark has dragged her foot**

As opposed to the fact that Denmark has dragged her foot, Britain had cancelled the broadcasting license of MED TV, the media organ of PKK/KONGRA-GEL, in 1999. And, in 2004, France had cancelled the broadcasting license of MEDYA TV, which was the continuation of MED TV. Germany also banned the activities of Roj TV in Germany as a result of the data obtained in the operations conducted in May and June, 2008. On June 19, 2008, Germany also banned Mezopotamya Broadcasting and VIKO TV, which included Roj TV.

### **He had said "we have freedom of expression"**

On November 15, 2005, Prime Minister Erdogan was going to have a press conference following his meeting with Rasmussen in Copenhagen, where he went to deliver a speech at the NATO Assembly. However, upon finding out that there were also Roj TV correspondents present, he had asked that these correspondents should be removed from the lounge and Rasmussen had criticized Erdogan, and said: "So long as the journalists act in compliance with the Danish laws, I will not remove any journalist from the lounge. The Danish police have started an investigation against the Roj TV. It is an ongoing investigation at present. As the Prime Minister, I will not make any interventions so long as the investigation continues. We have freedom of expression. The Danish government cannot monitor what appears in the media; and actually, it should not be monitored. In conclusion, the Danish Government cannot be held responsible for the exercise of democracy in the media."

Akat continued by saying: "There are about 200-300 thousand tourists going to Turkey from Denmark. Those who have seen our country think differently about Turkey. PKK cannot find the support it seeks in Denmark."

**De to ulmende kriser skaber stadig rystelser i Danmarks forhold til omverden**

Den ene sag, tegningerne, har gjort ytringsfrihed til et internationalt dansk varemærke og Danmark til et terrormål.

Den anden sag, ROJsagen, tester, om Danmark er 100 procent med i kampen mod terror, og om den i kamp vil sætte grænser for ytringsfriheden og dermed skade det dyrt købte varemærke.

Ukendte forbindelser Berlingske Tidende har gennem de seneste måneder undersøgt sagen mod ROJ TV og fremlagt dokumentation for, at der er forbindelser til PKK, som offentligheden hidtil ikke har kendt til, og som ledelsen i ROJ TV kategorisk har benægtet eksisterede - PKK er på EU's terrorliste.

I dag kan Berlingske Tidende offentliggøre nye oplysninger, der viser, at flere af Danmarks nærmeste samarbejdspartnere gentagne gange har lagt pres på Danmark for at smide ROJ TV ud af landet.

#### Formel protest fra USA

Sammenstødet mellem ytringsfrihed kontra terrorbekæmpelse, Muhammed-sag versus ROJ-sag, sker i de sidste dage af oktober 2005. Den 24. oktober afviser daværende statsminister Anders Fogh Rasmussen at mødes med ambassadører fra 11 muslimske lande, som protesterer over de »blasfemiske« tegninger i Jyllands-Posten.

Få dage forinden har Fogh udtalt: »Ytringsfriheden er selve det danske demokratis fundament. Ytringsfriheden er meget vidtrækkende, og den danske regering har ingen mulighed for at påvirke pressen.

« Den 26. oktober er daværende forsvarsminister Søren Gade til møde i det amerikanske forsvarsministerium, Pentagon, med sin amerikanske kollega Donald Rumsfeld.

Bag dem bliver en dansk diplomat fra ambassaden i Washington trukket til side af en højststående embedsmand fra USAs Udenrigsministerium.

Den danske diplomat rapporterer efterfølgende hjem, at amerikanerne er på vej til at »demarchere« i København.

USA vil med andre ord overdrage en formel protest i form af en skriftlig note: »Baseret på amerikansk efterretningsvirksomhed er man efterhånden meget bekymret over ROJ, som PKK bruger til at lave propaganda for sine terrorhandlinger samt til rekruttering,« skriver diplomaten i en e-mail, som Berlingske Tidende har fået aktindsigt i.

ROJ TV er begyndt at sende med dansk licens i 2004.

»Tyrkiet har en pointe« Diplomaten nævner også, at Tyrkiets premierminister under et besøg i USA har taget sagen op med præsident George W. Bush og udenrigsminister Condoleezza Rice, og at tyrkerne ifølge USA har »en pointe« : »Amerikanske efterretningsoplysninger peger på, at PKK efterhånden har udviklet sig til den største organiserede kriminelle organisation i Europa. PKK var nu indblandet i alt - fra prostitution og menneskesmugling til sortbørshandel. Problemet var, at PKK anvendte de indtjente midler til at gennemføre aktioner i det sydøstlige Tyrkiet. Der er efterhånden flere centre for PKK-aktive i Europa, og København var heriblandt.« To dage senere, den 28. oktober, er den tyrkiske ambassade i København vært for en reception i anledning af den tyrkiske nationaldag. En amerikansk diplomat gentager over for en dansk kollega, at USA er på vej med en kritisk note om ROJ TVs tilstedeværelse i Danmark.

Dagen efter, den 29. oktober, melder muslimske organisationer Jyllands-Posten til politiet for blasfemi og racediskrimination.

Presset tager til

Sådan fortsætter de to kriser med at krydse hinanden: På den ene side forsvarer regeringen ytringsfriheden som ukrænkelig over for muslimske lande, på den anden side er regeringen under pres fra sin nærmeste partner i kampen mod terror for at tage det ultimative indgreb i en TV-stations ytringsfrihed.

Det pres tager til den 4. november, da diplomater fra USAs ambassade møder op i Udenrigsministeriet og som bebudet afleverer en note: »Vi anmoder kraftigt den danske regering om at lukke og indefryse værdierne hos ROJ TV,« skriver amerikanerne: »I betragtning af dens opflammende programmer, dens forbindelser til andre PKK-frontorganisationer og de skridt, som andre europæiske regeringer har taget imod dens forgængere, bør disse enheder ikke nyde et safe haven i Danmark.« Noten rummer en redegørelse for Storbritanniens forbud mod det kurdiske MED TV i 1999 for opfordringer til had og Frankrigs tilsvarende forbud mod MEDYA TV i 2004. ROJ TV begyndte at sende få dage efter det franske forbud.

#### Usædvanlig hård kritik

En så hård kritik fra så tæt en allieret - i en terrorrelateret sag - er ganske usædvanlig, vurderer professor i europæisk historie Uffe Østergaard fra CBS, Handelshøjskolen i København.

»Det er overraskende, at USA har reageret så stærkt i denne sag. Givet det danske forhold til USA er det en stor ting, at Danmark ikke har gjort noget trods de amerikanske protester,« siger han.

Amerikanernes store bekymring stiger til decideret vrede få dage senere.

Den 19. november 2005 afslører Berlingske Tidende indholdet af den ellers dybt fortrolige note. Igen er der krisemøde i Udenrigsministeriet, hvor den amerikanske charge d'affaires i »stærke vendinger« beklager sig over lækkagen, fremgår det af et referat fra mødet. Det er Danmarks troværdighed, der står på spil.

Amerikanerne finder »det helt overraskende, at noget sådant kunne ske i et land som Danmark,« og de spørger, »hvorledes de ville kunne formidle yderligere materiale vedrørende ROJ TV/ PKK, uden at det ville havne i pressen.« De vil også gerne vide, om ministeriet har indledt en jagt på den, der havde lækket noten.

#### En umulig sag

En embedsmand tæt på forløbet fortæller i dag, at mange i ministeriet dengang tænkte: »For pokker, skal vi nu have en krise med amerikanerne.« Sagen udstiller, at der skulle en amerikansk reprimande til, før spørgsmålet om ROJ TV blev taget alvorligt i den danske centraladministration.

Som kilden beskriver det: ROJ-sagen var »irriterende«. En sag, »som vi alle gerne havde været foruden, for den var umulig at lande på en måde, så alle var tilfredse.« Professor Uffe Østergaard mener, at forklaringen på den danske nølen er oplagt: »Man er blevet fanget af Muhammed-krisen, hvor Danmark har gjort det svært for sig selv. Kan man lukke en TV-station samtidig med, at man står stejlt på ytringsfriheden? Det er det dilemma, som Danmark er ramt midt ned i.« Nonchalant holdning Siden oktober 2005 er indløbet en stribe andre og lige så utålmodige henvendelser fra andre samarbejdspartnere i kampen mod terror.

»Man kan være venlig og fortolke det som dansk konsekvens og beslutsomhed i forhold til ytringsfriheden.

Men sagen er nok nærmere et udtryk for vaghed og ubeslutsomhed.

I værste fald et udtryk for en ligegyldighed fra de danske myndigheders side,« siger Uffe Østergaard. Han minder om, at alarmklokkerne har ringet flere gange. Den tyrkiske premierminister Tayyip Recep Erdogan udvandrede i november 2005 fra et pressemøde i København med Anders Fogh Rasmussen i protest mod en tilstedevarende journalist fra ROJ TV. Samme Erdogan truede i fjor med et veto mod Fogh som NATO-generalsekretær.

»Så man burde måske overveje at bruge lidt flere kræfter på sagen. Der er en fornemmelse af, at Tyrkiet ikke er et stort og vigtigt land, og vi har en lidt nonchalant holdning over for Tyrkiet. Der er en solid anti-tyrkisk holdning herhjemme, så det er et nemt standpunkt at tage.

Men det er ikke et helt skønt billede, som Danmark sender til sine allierede,« fastslår Uffe Østergaard.

#### Er PKK terrorister?

Ekspert i international politik Peter Viggo Jakobsen fra Københavns Universitet tvivler på, at Muhammedkrisen bærer skylden, men er enig i, at der næppe er megen forståelse blandt Danmarks allierede for håndteringen af sagen mod ROJ TV.

»Det er nok snarere udtryk for, at beviserne ikke har været tungtvejende nok, og at Danmark ikke anser PKK for terrorister på linje med al-Qaeda. Opfattelsen er nok snarere, at PKK er en national selvstændighedsbevægelse, og derfor er man uenig i den hårde linje, som Tyrkiet har lagt over for PKK,« påpeger Peter Viggo Jakobsen.

Faktum er dog, at Danmark har været med til at sætte PKK på EUs terrorliste og dermed forpligtet sig til at modarbejde organisationen.

#### Belgien bevidst valgt

Præcis samme besked havde den daværende amerikanske viceudenrigsminister og chefkoordinator for terrorbekæmpelse, Frank Urbancic med sig, da han i 2008 besøgte Udenrigsministeriet i København. Det er uvist, hvem han mødtes med. Derimod står det klart, at han rejste fra Danmark med fornemmelsen af, at regeringen nølede og havde et »særligt problem«. Sådan udtrykte han det nogle dage senere, da han i Ankara mødtes med tyrkiske diplomater og journalister.

Berlingske Tidende har i det amerikanske udenrigsministerium fundet et referat af mødet. Af referatet fremgår, at PKK efter amerikansk vurdering bevidst har udvalgt sig Belgien som central for sine politiske og kriminelle aktiviteter i Europa - og Danmark til TV-stationen ROJ.

»Det virker nærmest, som om PKK har en håndbog i europæisk lovgivning, og de kender ethvert hul i loven - ethvert sted hvor de ikke kan rammes på tværs af grænser.

De har fundet ud af, at de kan gå nøjagtig så langt og ikke længere i Danmark i forhold til ytringsfriheden,« forklærede Frank Urbancic.

Er danskerne ikke »ekstremt naive«, blev han spurt: »Fordomme om Tyrkiet er det, du oplever overalt i Europa, det er virkelig noget, vi er nødt til at overvinde,« lød svaret: »Hvad angår ROJ TV specifikt, er vi overbeviste om, at det er en front for en terrororganisation, det er en propagandaarm. Danskerne kan tale for sig selv, men de har et særligt problem på grund af tegningerne, de er opsatte på ikke på nogen måde at tillade sig selv at blive set som dem, der begrænser ytringsfriheden. Og dette er et eksempel på den klogskab, jeg nævnte, hos de mennesker, som vi forsøger at modarbejde.« Den amerikanske viceudenrigsminister oplyste, at USA »bestemt opfordrede« danskerne til at komme i sving med efterforskningen imod ROJ TV.

#### Fakta: Presset på ROJ TV -og Danmark

En række af Danmarks nærmeste samarbejdspartnere i kampen mod terror er langt hårdere end danskerne i deres syn på ROJ TV, der sender med dansk licens. USA, Tyskland og Belgien opfatter officielt ROJ TV som styret af PKK, der er på EUs og USAs terrorliste.

Uden for kortet USA USA afleverede i 2005 en officiel protest imod den danske sendetilladelse til ROJ TV. I 2008 var den amerikanske anti-terrorkoordinator i Danmark for at få lukket ROJ TV: "Stationen er en del af PKK. Det er der ingen tvivl om," lød beskeden. USA 's finansministerium har sat PKK-lederen, Zübeyir Aydar, på en officiel liste over narkobagmænd. Aydar har holdt møde med ROJ TVs bestyrelsesformand, Henrik C. Winkel.

**TYSKLAND** Den tyske sikkerhedstjeneste rubricerer ROJ TV som propagandakanal for PKK. Det tyske indenrigsministerium forbød i 2008 modtagelse af ROJ TVs signal. Forbuddet blev ophevet i år af tysk domstol. Dommen lød, at nok var der ført bevis for, at ROJ TV kunne forbydes, men i forhold til EU-regler kan kun det land, som udsteder sendetilladelse, udstede et forbud -altså Danmark. Sagen er nu på vej til EF-Domstolen. De tyske myndigheder har for nylig rykket Danmark for, hvornår den fem år lange efterforskning mod ROJ TV er færdig.


**BELGIEN** Den belgiske sikkerhedstjeneste rubricerer ROJ TV som styret af PKK. Belgiske myndigheder har gennemført flere aktioner mod ROJ TVs studier uden for Bruxelles og produktionsselskabet ROJ NV, der leverer hovedparten af nyheds-og debatprogrammerne til ROJ TV. I marts blev flere anholdt -bl. a. Remzi Kartal og Zübeyir Aydar, henholdsvis formand for og eksekutivmedlem af Kongra-Gel (PKKs officielle navn i dag). Kartal og Aydar har mødtes med bestyrelsesformand i ROJ TV, Henrik C. Winkel.

**SCHWEIZ Schweiz** har to gange skriftligt spurgt Radio- & TV-nævnet i Danmark, hvorfor ROJ TV ikke er forbudt. **ENGLAND** Briterne lukkede i 1999 MED TV -en forløber for ROJ TV -på grund af opfordringer til had (vold og terror mod den tyrkiske stat). Har forbudt indrejse til Remzi Kartal. Kartal har mødtes med ROJ TVs bestyrelsesformand, Henrik C. Winkel.

**FRANKRIG** Lukkede i 2004 MEDYA TV på grund af opfordringer til had og forbindelse til PKK. Få dage senere begyndte ROJ TV at sende fra Danmark. Fransk politi anholdt i marts i år flere nuværende og tidligere ansatte i ROJ TV. Alle er løsladt igen.

**TYRKIET** Tyrkiets premierminister Erdogan udvandrede i 2005 fra pressemøde i København med daværende statsminister Anders Fogh Rasmussen. Det skete i protest mod tilstedeværelsen af en journalist fra ROJ TV. Erdogan truede i 2009 med et veto mod Fogh som NATOs generalsekretær med ROJ TV som primær begrundelse. Den tyrkiske ambassade har i mindst syv tilfælde siden 2004 henvendt sig til den danske regering med krav om at få lukket ROJ TV. Ambassaden har tre gange klaget til Radio- & TV-nævnet over ROJ TVs udsendelser, som ifølge tyrkerne opfordrer til had. Alle klager er blevet afvist. Den danske ambassadør i Tyrkiet er mindst én gang blevet indkaldt til samtale af den tyrkiske regering. Senest har den tyrkiske ambassadør den 5. maj i år i et møde med justitsminister Lars Barfoed (K) presset på for at få en afklaring på sagen.

### **Another empty promise**

The promise, which was said to have been made for the closure of Roj TV, has also turned out to be void just as the promise allegedly made for an apology on the caricatures before Turkey approved Rasmussen's NATO position as the Secretary General. Ambassador Vahr said: "The PKK is a terror organization but Roj TV is also broadcasting under the Danish license."

## **THE NEWS ON 'ROJ TV WOULD BE CLOSED' ALSO TURNED OUT TO BE A SHAM**

**After the allegation that Rasmussen would apologize for the caricatures on Prophet Mohammed, the 'leaked' news that Denmark had promised to close the Roj TV also turned out to be a lie**

After the news that the Danish Prime Minister Anders Fogh Rasmussen promised 'to apologize for the caricatures on Prophet Mohammed' in exchange for the position as the NATO Secretary General, the news that Denmark would close the Roj TV, the pro-PKK broadcasting company, has also turned out to be a lie. The Ambassador of Denmark in Ankara, Jesper Vahr, has officially denied the news that they had made a promise on the closure of the Roj TV.

Upon Ankara's veto against Rasmussen's becoming the Secretary General of the NATO at the Summit on April 4<sup>th</sup>, where Abdullah Gü'l had represented Turkey, had led to a crisis. The US President Barrack Obama had intervened and Turkey had lifted her veto. After this decision, the governmental sources leaked that Rasmussen had promised "to apologize for the caricatures of the Prophet Mohammed, which had been published in the Danish

"newspapers" and "to close Roj TV". These news were covered extensively particularly in the pro-AKP media organs.

#### **Rasmussen did not confirm**

However, Rasmussen who came to Istanbul for the 2<sup>nd</sup> Forum of the Alliance of Civilizations did not apologize for the caricatures on Prophet Mohammed; neither did he confirm that he had made such a promise.

On the closure of the Roj TV, Rasmussen had also conveyed ambiguous messages. The Ambassador of Denmark in Ankara, Vahr, has put the final full-stop to these allegations.

The Ambassador pointed out that they did not support the PKK and said the following: "Denmark firmly condemns the PKK as a terrorist organization. Moreover, Denmark was instrumental in ensuring that the PKK was put on the EU's terrorist list. Roj TV is broadcasting on the Danish license. The issuing of licenses to TV broadcasters serves a number of technical and administrative purposes. As in all other cases, this broadcasting license does in no way imply Danish authorities' endorsement of or support for the editorial line of the broadcaster in question. As all other TV-broadcasters, Roj TV has to abide by relevant Danish legislation. As long as it does so, the government cannot revoke a broadcasting license."

#### **'The decision lies with the judiciary'**

In response to the question if there was an investigation against Roj TV, Ambassador Vahr furnished the following response: "The Danish prosecuting authorities (the public prosecution) are undertaking a criminal investigation into Roj TV. The decision on whether or not to take the matter to court rests exclusively with the prosecuting authorities. This is not a political decision. The decision of the prosecution authorities will be based on whether it is assessed that there is sufficient evidence that Roj TV is violating the Danish criminal law. If evidence can be provided that Roj TV violates the Danish criminal law, the necessary consequences will be drawn. The Danish government cannot interfere with the work of the relevant Danish authorities in an ongoing investigation."

As to the question on whether Roj TV will be closed, Vahr responded by saying: "Denmark cannot give such guarantees because this is not a political decision."

As to Turkey's membership to the EU, the Ambassador made the following assessments: "Denmark welcomes the commencement of Turkey's accession negotiations with the EU, the objective of which is Turkish membership of the EU. The Danish parliament confirmed this longstanding basic position in a vote following a debate dedicated to Turkey and the EU on March 26, 2009."

## IS THE NEWS ON 'ROJ TV TO BE CLOSED' A SHAM

**Following the allegation that Rasmussen will apologize for the caricatures on Prophet Mohammed, the Danish front has denied that Denmark made a promise for the closure of Roj TV.**

After the news that the Danish Prime Minister Anders Fogh Rasmussen promised 'to apologize for the caricatures on Prophet Mohammed' in exchange for the position as the NATO Secretary General, the news that Denmark would close the Roj TV, the pro-PKK broadcasting company, has also turned out to be a lie. The Ambassador of Denmark in Ankara, Jesper Vahr, has officially denied the news that they had made a promise on the closure of the Roj TV.

Upon Ankara's veto against Rasmussen's becoming the Secretary General of the NATO at the Summit on April 4<sup>th</sup>, where Abdullah Güл had represented Turkey, had led to a crisis. The US President Barrack Obama had intervened and Turkey had lifted her veto. After this decision, the governmental sources leaked that Rasmussen had promised "to apologize for the caricatures of the Prophet Mohammed, which had been published in the Danish newspapers" and "to close Roj TV". These news were covered extensively particularly in the pro-AKP media organs.

### Rasmussen did not confirm

However, Rasmussen who came to Istanbul for the 2<sup>nd</sup> Forum of the Alliance of Civilizations did not apologize for the caricatures on Prophet Mohammed; neither did he confirm that he had made such a promise.

On the closure of the Roj TV, Rasmussen had also conveyed ambiguous messages. The Ambassador of Denmark in Ankara, Vahr, has put the final full-stop to these allegations.

The Ambassador pointed out that they did not support the PKK and said the following: "Denmark firmly condemns the PKK as a terrorist organization. Moreover, Denmark was instrumental in ensuring that the PKK was put on the EU's terrorist list. Roj TV is broadcasting on the Danish license. On April 6<sup>th</sup> Rasmussen came to Turkey and fell down the stairs of the hotel and had dislocated his arm.

## **ROJ TV THREATENED, DENMARK REMAINED SILENT**

**Roj TV known for its pro-PKK broadcasts and Denmark, the centre of the caricature crisis causing uproar in the Muslim world, did not keep her promise. She remained silent towards Roj TV, broadcasting the statement of the Kurdistan People's Initiative – the side organization of the PKK – making the AKP administrators and Fetullah Gülen an open target**

The statement criticizes the recent operations directed against the DTP and briefly says: "We know the reason for the operations. The institutions belonging to the Gülen Congregation and the AKP administrators in the Kurdistan and Turkish metropolises are our open target. Every act conducted against all the administrators, the institutions and organizations affiliated with the AKP and the institutions serving for the Fetullah Gülen gang in all the metropolises of Turkey and particularly in the cities of Kurdistan are a legitimate right."

For a long time Denmark had kept her ears closed to Turkey's requests in connection with the Roj TV, which makes propaganda for the PKK – until the election for the NATO Secretary General. The former Danish Prime Minister Anders Fogh Rasmussen, who became the Secretary General for the NATO with Turkey's approval, had said that his country would take all the measures in order to prevent terrorist acts and he had said that Roj TV would be closed.



### **Seize Roj TV**

#### **New Initiative from the Copenhagen Prosecutor's Office**

In a surprise move yesterday evening, the Copenhagen Prosecutor's Office demanded that Roj TV, the mouthpiece of the PKK in Europe, cease broadcasts at once and that all assets of the Mesopotamia Broadcasting company, which is connected to Roj TV, be seized. In a writ to the court, the Copenhagen Prosecutor's Office argued that interviews and footage of attacks broadcast on Roj TV supports the PKK and encourages people to join the organization. The same prosecutor's office had seized all bank accounts of Roj TV on August 30.

#### **Interesting Timing**

Roj TV broadcasts under a license issued by Denmark. Turkey had asked Denmark through several initiatives to stop Roj TV broadcasts, but had failed to get a result. Interestingly, the move by the Copenhagen Prosecutor's Office followed Turkish efforts on the international arena -- both by ministers and the undersecretary of MIT (the Turkish secret service) -- to disband the PKK. It was also noted that the prosecutor's decision came before NATO Secretary General Anders Fogh Rasmussen's visit to Turkey on October 7 during which he will discuss the fight against terrorism. When Turkey approved Rasmussen as secretary general at the NATO summit last year, it listed as conditions the appointment of a Turkish deputy secretary-general and the closure of Roj TV by Denmark.

#### **Claims of Danish prosecutor in Turkey**

Meantime, there are claims that a Danish prosecutor (\*) investigating Roj TV is in Turkey and has met both Turkish judicial officials as well as PKK members-turned-informers.

(\*) Translator's note: The word used in the Hurriyet article is **avci**, which means "hunter". I believe it is a typo and that the intended word is actually **savci**, which means "prosecutor"
