Hereby a preliminary response from Denmark as to the follow up questions to the meeting chaired by the Commission on 15 September 2010 on the Greek Migration Action Plan

Denmark supports the intention of the Commission to take on the very important coordinating role as regards assistance to Greece in the implementation of its Migration Actions Plan that was discussed at the meeting chaired by the Commission on 15 September 2010.

Denmark has implemented capacity building projects in various countries on migration management, inter alia Twinning projects in Hungary, Poland, the Baltic countries, Bosnia, Turkey and Romania. The cooperation between Denmark and its Twinning partners has been very fruitful. Further, Denmark and Sweden have assisted Greece in capacity building activities in 2009 focusing on asylum procedures, reception and return.

The Danish Ministry of Refugee, Immigration and Integration Affairs, the Danish Immigration Service, the National Commissioner of Police and the Danish Ministry of Foreign Affairs are able to provide expertise relevant to the implementation of the Greek Action Plan in the area of refugee status determination; asylum procedures (a new effective system was implemented this year); COI; statistics; Lean-management; electronic case handling; business intelligence; reception facilities; return management and protection of refugees and displaced in the region of origin (Danish Regions of Origin Program). The Danish approach as regards capacity building has a regional focus on countries of origin and transit. This in our view would be relevant also when it comes to Greece and is in line with the strong focus in the Stockholm Programme on the external dimension of migration and asylum focusing *inter alia* on countries of origin and transit, two of them being Turkey and Syria.

Moreover, we have contacted the Danish Refugee Council (a Danish NGO and implementing partner of UNHCR and involved in capacity building projects inter alia as part of the Danish regions of Origin Program) as well as the Danish Red Cross which operates most of the Danish asylum reception centers. Their expertise is also likely to be made available.

Due to the tight budgetary situation in the Danish administration, we would be interested to know more about possibilities for funding from the Commission to cover expenses related to Danish assistance (travel costs, per diems and overhead). Please note that EU funding is not a precondition for a contribution from our side.

We look forward to the future planning of the assistance to Greece. We hope that the Commission with the necessary input from Member States will be able to provide a clear overview on how Member States could best assist Greece in upgrading its asylum and migration system. Thus, we agree with the Commission that we need to react now and before the Asylum Support Office becomes fully operational.

Further to our letter of 26 November and our discussions in Brussels on 30 November, please find below the terms and conditions that will enable the Commission to reimburse your experts' travel to Greece. The mission should take place from 13 to 21 December 2010.

Before each mission can take place, the expert must have received an individual invitation letter from the Commission. The letter will include further information regarding the objectives of the mission, the place of work and the colleagues with whom experts will be working in Greece. It will also include all the necessary information needed to have the costs reimbursed. This letter will be sent to experts shortly.

A) The name and contact details of each expert and the time of the mission of each must be communicated to the Commission.

B) Bank forms

Each expert will need to complete a form following the below link for themselves and for their individual bank account details. Note that each form has a part that must be completed by the individual bank. It is important that all forms are signed and dated.

This link includes the appropriate forms for all community languages. The forms must be completed and submitted to the Commission as soon as possible and in any even before the final reimbursement can be made.

C) Legal entity form:

D) The rules for reimbursed are as follows:

1

The Commission shall not be liable for any material; non-material or physical damage suffered by invited experts or those responsible for accompanying a disabled expert in the course of their journey to or stay in the place where the meeting is held, unless such harm is directly attributable to the Commission. In particular, invited experts

who use their own means of transport for travelling to such meetings shall be entirely liable for any accidents that they might cause.

2

(1) All experts shall be entitled to the reimbursement of their travel expenses from the place specified in their invitation (work or home address) to the place of the meeting, by the most appropriate means of transport given the distance involved. In general, for journeys of less than 400 km (one way, according to official distance by rail) this shall be first-class rail travel, and for distances of more than 400 km economy class air travel.

If the journey by air involves a flight of 4 hours or more without stopovers the cost of a business class ticket shall be reimbursed.

(2) The authorising officers for commitments shall specifically try to ensure that meetings are organised in such a way as to enable experts to benefit from the most economical travel rates.

The authorising officers for payments shall scrutinise particularly closely any requests for reimbursement involving abnormally expensive flights. They shall have the right to carry out any checks that might be needed and to request any proof from the expert required for this purpose. They shall also have the right, where it appears to be justified, to restrict reimbursement to the rates normally applied to the usual journey from the expert's place of work or residence to the meeting place.

- (3) Travel expenses shall be reimbursed on presentation of original supporting documents: tickets and invoices or, in the case of online bookings, the printout of the electronic reservation and boarding cards for the outward journey. The documents supplied must show the class of travel used, the time of travel and the amount paid.
- (4) The cost of travel by private car shall be reimbursed at the same rate as the first-class rail ticket.
- (5) If the route is not served by a train the cost of travel by private car shall be reimbursed at the rate of EUR 0.22 per km.
 - (6) Taxi fares shall not be reimbursed.

- (1) The daily allowance paid for each day of the meeting is a flat rate to cover all expenditure at the place where the meeting is held, including for example meals and local transport (bus, tram, metro, taxi, parking, motorway tolls, etc.), as well as travel and accident insurance.
- (2) The daily allowance shall be EUR 82.00.
- (3) If the place of departure cited in the invitation is 100 km or less from the place where the meeting is held, the daily allowance shall be reduced by 50%.
- (4) The accommodation allowance will be **EUR 140.00 per** night in a hotel. The number of nights may not exceed the time of the mission + 1 day.

D) PAYMENTS

To be reimbursed, the attached form will need to be filled in by experts, including also the above-mentioned documents (e.g. hotel or travel invoices) as well as a complete Mission report.

The Commission will make any payment within 20 days after the approval of the Mission report and provided all the necessary documents are completed correctly and the legal entity and bank account have been duly registered (in advance) with the Commission. Two months ago, Greece sent its National Action Plan for Migration Management to the European Commission. The plan aims at improving the migration management in Greece, encompassing the screening of illegal migrants, a new asylum system, improved detention and reception facilities, repatriation and returns.

However, an Action Plan is not enough. It must be followed by concrete action.

It is absolutely crucial to initiate a series of activities aimed at strengthening the authorities' migration management in Greece. This will not only be in the interest of the asylum seekers with genuine needs for international protection, but it will also underpin our common efforts to combat illegal immigration to the EU.

EU efforts to assist Greece must be increased and intensified. It is of the utmost importance that all Member States work together in a spirit of solidarity. The Commission is already doing a tremendous effort to ensure that Greece will receive enough support to improve their asylum and migration system. We, as the responsible Ministers in the Member States, should also engage ourselves in order to further speed up the progress.

Bearing in mind the difficult work ahead and the need to rapidly and efficiently implement the Greek Action Plan, I would appreciate if we could discuss the Greek Action Plan and its implementation at the Council meeting on 8 November 2010, e.g. in relation with the agenda item *Common European Asylum System – State of Play*. I would also suggest that we commit ourselves to discuss this issue at all subsequent JHA Council meetings until the Dublin system will be well-functioning once again.

Finally, I would like to use this opportunity to express my appreciation for the excellent work done by the Belgian Presidency so far.

Thank you for your letter dated 4 July 2008 informing me about the decision taken by the Danish Minister of Refugees, Immigration and Integration Affairs to suspend for the time being transfers to Greece of unaccompanied minors who are asylum seekers, pursuant to the Dublin Regulation.


We consider that this decision is in full compliance with the Dublin Regulation, namely with its Article 3(2), which indeed allows a Member State to decide, upon its own initiative, to examine an application for asylum lodged with it by a third-country national and not to return an asylum seeker to the Member State responsible, for instance when it considers that the latter one is not in a position to offer adequate reception conditions.

I take this occasion to inform you that Greece has recently notified to the Commission the relevant legal measures transposing the Community asylum instruments. These are currently being examined by my Department in order to assess their compliance with the EC acquis. In particular, regarding the Dublin Regulation and following the decision taken by the Commission on 31 January 2008 to refer Greece to the Court of Justice, Greece communicated a new legal measure which ensures respect for the principle of an effective access to the procedure for determining refugee status, laid down in Article 3(1) of the Dublin Regulation.

The Commission will continue carefully to monitor the general asylum situation in Greece in order to ensure that Greece fulfils its obligations under the asylum acquis, this being a pre-condition for the smooth operation of the Dublin system, in a spirit of mutual trust and cooperation.

I would like to thank you for a pleasant and productive meeting in Copenhagen on June 19th 2008. The future immigration reality will certainly be challenging with an exciting new presidency ahead of us.

In the meeting we had a chance to discuss the Dublin Regulation with regard to Greece. As you remember, I mentioned the Danish concerns and the possibility of a future suspension of the use of the Dublin Regulation with regard to unaccompanied minors where Greece following the Dublin Regulation would be responsible.

I would like to inform you on recent developments on the matter since our meeting.

With regards to transfers from Denmark to Greece of unaccompanied minor asylum seekers pursuant to the Dublin Regulation, the Minister of Refugees, Immigration and Integration Affairs decided as of June 27th 2008, in view of the best interests of the child, cf. Article 3 of the United Nations Convention on the Rights of the Child, and on the basis of recently gathered information of the Swedish Migration Board in the enclosed report (in Swedish only) regarding the reception conditions in Greece of unaccompanied minors, for the time being, to suspend transfers of unaccompanied minor asylum seekers to Greece pursuant to the Dublin regulation.

Thus, the Danish alien authorities will in these cases for the time being apply Article 3, paragraph 2, of the Dublin Regulation and accordingly consider the application of the unaccompanied minor asylum seekers for asylum in Denmark except in those circumstances where information on family relations as mentioned in Article 6 and Article 15, paragraph 3, suggests that it will not be in the best interests of the child to consider the application for asylum in Denmark.

In our view it is therefore even more important that the Commission liaises even closer with Greece in order to ensure that other Member States – without risking a violation of their international obligations – can use the Dublin Regulation "normally" vis-à-vis Greece.

Dear Cecilia,

It is with great concern that I have read the ruling of 21 January 2011 by the European Court of Human Rights in the case of M.S.S. vs. Belgium and Greece (application no. 30696/09).

The European Court of Human Rights has found that Greece has violated the European Convention on Human Rights both because of the detention conditions of the applicant and his general living conditions in Greece and due to the deficiencies in the asylum procedure.

The ruling by the European Court of Human Rights highlights the indisputable need to provide support to Greece in the field of asylum. There is no time to waste, and I am personally very preoccupied by the gravity of this situation and the necessity of EU to make a joint effort to solve it. This demands assistance to the Greek authorities but also a clear message to Greece about the importance of living up to European standards.

I trust in you and the Commission to take quick and efficient action including a rapid implementation of the Greek National Action Plan for Migration Management. In order to re-establish the asylum system in Greece we all need to further increase and intensify our assistance to the Greek authorities. There has to be movement on all sides to recognise that we now need to act rather than to talk. Denmark stands ready to continue our support to Greece.

Greece has of course the primary responsibility for ensuring the improvements of its asylum procedures as well as the detention and living conditions for asylum seekers. Further steps following the Commission's opening letter to Greece from October 2009 could perhaps encourage Greece to take the necessary steps to ensure action.

I would like to mention our positive and valuable experiences with the involvement of NGO's in the Danish asylum system, whereby the Danish Red Cross plays an important role in the accommodation of asylum seekers and the Danish Refugee Council for example is providing counselling to asylum seekers. Perhaps this model could be a source of inspiration in order to engage all available resources and the involvement of civil society. The Danish Red Cross and the Danish Refugee Council have indicated to me their willingness to contribute. In the Commission's future coordinating work it is important also to include such offers from civil society.

In this context, it is of course important to ensure the necessary funding.

Finally, I would like to inform you that following this ruling, I have instructed the Danish Immigration Service to start examining the asylum applications that should otherwise have been examined in Greece. The decision will take effect immediately and will be upheld until the situation in Greece has improved.

Please find enclosed a copy of my letter to the Hungarian Presidency regarding the forthcoming JHA Council meeting on 24-25 February 2011.

As a follow up to my recent letter regarding the situation in Greece I would like to inform you that a mission of Danish officials together with the Danish Refugee Council visited Greece to look into possibilities to assist Greece in its implementation of the National Action Plan for Migration Management. The idea with this mission was to assess how we can swiftly add value to the ongoing process in Greece. I enclose our first outline for a Danish action plan for this bilateral assistance.

In brief, I appreciate the coordinating role of the Commission in the assistance to Greece. I hope that bilateral initiatives possibly with the involvement of civil society and international organisations can add value and momentum to the process. The Danish action plan might also inspire other Member States that are also planning supplementary bilateral initiatives. A copy of this letter has also been sent to other colleagues at the JHA Council as well as to the Presidency.

I would appreciate if the Commission could advise Member States on the exact possibilities on financing the costs related to assistance offered to Greece in the implementation of its action plan – for example at the JHA Council meeting later this month.

Immediate action of course also presupposes that Greece is both willing and able to make use of the assistance offered so that we build up a permanent capacity in a true partnership. Greece has the primary responsibility to implement its action plan and re-establish an asylum and migration system that is compliant with EU and international standards.

I look forward to the discussions at JHA Council meeting on 24-25 February 2011. I see the meeting as pivotal in our deliberations on how we can reach tangible outputs paving the way for swift, significant and sustainable improvements in Greece.

Preliminary Danish Action Plan on bilateral assistance to Greece

Denmark remains committed to assist Greece in its implementation of the National Action Plan on Migration Management. The idea of the bilateral assistance offered is to add value and momentum to the ongoing process.

The outcome of a recent mission by Danish officials and the Danish Refugee Council to Greece is a first outline for a Danish action plan for this bilateral assistance. The Danish Red Cross also is ready to offer assistance. Denmark sees a particular relevance of such bilateral assistance in the Danish model on asylum and migration management. The Danish model is nongovernmental, each of which have clearly defined tasks. This model ensures an effective, pragmatic and realistic asylum system in line with characterised by close working relationship with flexible procedures and a frank dialogue between stakeholders, both governmental and international standards.
